First of all, be honest (remember, if you get this job, the hiring manager will be calling your former bosses and co-workers!). Then, try to pull out strengths and traits you haven't discussed in other aspects of the interview As Process Area Supervisor, such as your strong work ethic or your willingness to pitch in on other projects when needed.

Ans:

Everyone has failed, so don't play dumb or claim you've never messed up As Process Area Supervisor. Think of a time when a work-related situation didn't turn out quite as you had hoped. Also, they should explain how these strengths will be useful in the job you're applying for, and use this question to say something interesting about themselves.
