## Question - 1:

Can you describe your ideal boss/supervisor?

### Ans:

During the interview As Courtroom Reporter process employers will want to find out how you respond to supervision. They want to know whether you have any problems with authority, If you can work well as part of a group (see previous question) and if you take instructions well etc. Never ever ever, criticize a past supervisor or boss. This is a red flag for airlines and your prospective employer will likely assume you are a difficult employee, unable to work in a team or take instruction and side with your former employer.

## Question - 2:

Can you explain why you changed career paths As Courtroom Reporter?

### Ans:

Don't be thrown off by this question-just take a deep breath and explain to the hiring manager why you've made the career decisions As Courtroom Reporter you have. More importantly, give a few examples of how your past experience is transferable to the new role. This doesn't have to be a direct connection; in fact, it's often more impressive when a candidate can make seemingly irrelevant experience seem very relevant to the role.

It's OK to say that you're not quite sure what the future holds, but that you see this experience playing an important role in helping you make that decision.

Also - make sure if you aim high you can back it up with facts and your previous results so that you can make a strong case.
