**Question - 7:**

Do you ever take work home with you?

**Ans:**

\* Make sure to give an honest answer. Lying about taking work home may turn out badly for you if it is required and you do not do it.

### **Question - 50:**

It's easy to talk about what you liked about your job in an interview, but you need to be careful when responding to questions about the downsides of your last position. You don't want the interviewer to think that you'll speak negatively about this job or the company should you eventually decide to move on after they have hired you.

### **Question - 51:**

#### **Ans:**

For example, "I'd really love to be part of product development from beginning to end, and I know I'd have that opportunity here." And if you were let go? Keep it simple: "Unfortunately, I was let go," is a totally OK answer.
